- Attendee list is MAIL only. Email, phone and fax are **NOT** included.
- The AHA International Stroke Conference list is for a one-time use to promote your participation at AHA International Stroke Conference 2023 and this list will not be sold or used to send catalogs or other general information. Lack of compliance will result in a loss of priority points for the exhibiting company.
- Mailers must promote exhibitor's presence at AHA International Stroke Conference 2023. Uses of AHA logos is **NOT** permitted. Mailers cannot contain messaging that insinuates the mailer is being sent on behalf of AHA.
- Mail lists are for a **ONE TIME** use only.
